

Generic Marking Principles

These general marking principles must be applied by all examiners when marking candidate answers. They should be applied alongside the specific content of the mark scheme or generic level descriptors for a question. Each question paper and mark scheme will also comply with these marking principles.

GENERIC MARKING PRINCIPLE 1:

Marks must be awarded in line with:

- the specific content of the mark scheme or the generic level descriptors for the question
- the specific skills defined in the mark scheme or in the generic level descriptors for the question
- the standard of response required by a candidate as exemplified by the standardisation scripts.

GENERIC MARKING PRINCIPLE 2:

Marks awarded are always whole marks (not half marks, or other fractions).

GENERIC MARKING PRINCIPLE 3:

Marks must be awarded **positively**:

- marks are awarded for correct/valid answers, as defined in the mark scheme. However, credit
 is given for valid answers which go beyond the scope of the syllabus and mark scheme,
 referring to your Team Leader as appropriate
- marks are awarded when candidates clearly demonstrate what they know and can do
- marks are not deducted for errors
- marks are not deducted for omissions
- answers should only be judged on the quality of spelling, punctuation and grammar when these features are specifically assessed by the question as indicated by the mark scheme. The meaning, however, should be unambiguous.

GENERIC MARKING PRINCIPLE 4:

Rules must be applied consistently e.g. in situations where candidates have not followed instructions or in the application of generic level descriptors.

GENERIC MARKING PRINCIPLE 5:

Marks should be awarded using the full range of marks defined in the mark scheme for the question (however; the use of the full mark range may be limited according to the quality of the candidate responses seen).

GENERIC MARKING PRINCIPLE 6:

Marks awarded are based solely on the requirements as defined in the mark scheme. Marks should not be awarded with grade thresholds or grade descriptors in mind.

	To be awarded the mark the response must include understanding of increasing levels of or more connection/dependence.	
	Accept more connection or more dependence alone. Both elements are not required.	
1(b)	Candidates may identify the following causes of globalistion:	2
	 faster communication improved transport more free trade new technology 	
	1 mark should be awarded for each correctly identified cause up to a maximum of 2 marks.	
	Further guidance	
	The only acceptable answers are listed above. However, candidates may use their own words.	
	The meaning of the whole phrase must be evident e.g. faster communication. The changing nature of the cause must be present.

	Candidates may give the following explanations, any of which could be used, to justify their choice:	
	 the number of people affected the range of impact e.g. number of countries/businesses/organisations affected 	
	the depth of impact e.g. how much difference will be made to how connected/dependent people are globally	
	 the timescale for making a difference costs availability of resources 	
	other reasonable response	
	Further guidance – candidates are most likely to discuss causes from Source 1 as listed above. However, the assessment is focused mainly upon their reasoning/justification and therefore additional causes should be credited.	
	The following levels of response should be used to award marks:	
	Level 3 (3 marks) Good response Clearly reasoned explanation explicitly linked to a cause with one developed point or three relevant but undeveloped points.	
	Level 2 (2 marks) Reasonable response Some explanation with two (or more) undeveloped points. The link between the explanation and a cause may be implicit or unclear at times.	
	Level 1 (1 mark) Limited response Limited and/or tangential explanation which may not be linked to cause.	
	Level 0 (0 marks) No relevant response or creditworthy material.	
	Further Guidance	
	If the response only identifies a cause without attempted explanation, no marks should be awarded.	
	If the response is direct copying from the sources without elaboration then can only reach L1.

	Candidates are likely to identify the following national consequences of globalisation:

	3 marks are available for the explanation of each consequence. A total of 6 marks (3 marks + 3 marks) are therefore available for the questions as a whole.	
	The following levels of response should be used to award marks:	
	Level 3 (3 marks) Good response A clear and full explanation of the consequence explicitly related to the context – local or national.	
	Level 2 (2 marks) Reasonable response A basic or partial explanation of the consequence generally related to the context – local or national.	
	Level 1 (1 mark) Limited response An identification of a consequence with limited or no explanation related to the context – local or national.	
	Level 0 (0 marks) No relevant response or creditworthy material.	
	Further Guidance	
	If response considers more than one consequence, only award for one consequence take the most effective discussion.

	Candidates are likely to discuss the following evaluative points relating to Source 3:	
	Strengths: uses many examples measured tone of language clear argument and easy to follow uses a source as evidence based on some research	
	 Weaknesses: few facts and statistics to back up claim source not referenced potential newspaper bias author unknown – difficult to verify knowledge claims little evidence mainly assertion 	
	The following levels of response should be used to award marks:	
	Level 3 (5–6 marks) Good response Clearly reasoned, credible and structured evaluation; two (or more) developed points clearly linked to the issue, with some other undeveloped points; or a wide range (four or more) of clearly appropriate undeveloped points.	
	Evaluation is clearly focused on the reasoning and/or evidence, its strengths and weaknesses and the way it is used to support the claim.	
	Level 2 (3–4 marks) Reasonable response Reasonable evaluation mainly focused on the reasoning and/or evidence, its strengths and/or weaknesses, and the way it is used to support the claim. The response may contain one (or more) developed point(s), with some other undeveloped points. Some (two or more) undeveloped points may be sufficient.	
	Level 1 (1–2 marks) Limited response Limited evaluation which is often unsupported and asserted. The response is clear in part but is incomplete and generalised. It contains one undeveloped point only. Answers at this level may repeat source material with little understanding. May describe personal opinion on the issue.	
	Level 0 (0 marks) No relevant response or creditworthy material.

	Possible sources of information: national and local governments and their departments international organisations, e.g. United Nations; UNESCO experts in culture/international relations research reports pressure groups, charities and NGOs media and the internet other relevant response	
	Possible methods: review of secondary sources/literature/research/documents interview relevant experts, elderly, carers, families internet search questionnaires surveys experiment other relevant response	
	The following levels of response should be used to award marks.	
	Level 4 (7–8 marks) Very good response Clearly reasoned, credible and structured explanation of a range of ways to test the claim. The response contains three (or more) developed points, and may contain some undeveloped points.	
	The response is clearly and explicitly related to testing the claim.	
	Level 3 (5–6 marks) Good response Reasoned and mainly credible explanation of ways to test the claim. The response contains two (or more) developed points, and may contain some undeveloped points.	
	The response is related to testing the claim.

	There is little relevance in the response to testing the claim or the methods, sources and types of information are generally not appropriate for the claim being tested.	
	Level 0 (0 marks) No relevant response or creditworthy material.

	Candidates are likely to identify the following possible reasons for bias from Brigita's background/experience:	
	 Father's loss of job on the farm Experience of immigration locally from overseas Immigrants taking over jobs and shops Loss of heritage and culture Overcrowding in schools and hospitals 	
	Candidates are likely to identify the following evidence of bias from Brigita's statement:	
	 Lack of balance/focus on negative aspects of globalisation Emotive language Lack of evidence to support opinion Focused only on personal/local experience 	
	The following levels of response should be used to award marks:	
	Level 3 (3 marks) Good response A clear and full explanation of why the statement may be biased supported with evidence from the statement. The response contains two (or more) points, with one (or more) of these developed.	
	Level 2 (2 marks) Reasonable response A basic or partial understanding/explanation of why the statement may be biased. The response contains one developed point or two undeveloped points.	
	Level 1 (1 mark) Limited response A Limited explanation of why the statement may be biased. The response contains one undeveloped point.	
	Level 0 (0 marks) No relevant response or creditworthy material.

	Candidates are expected to evaluate the arguments presented in Source 4 and compare their effectiveness. They should make a supported judgement with some explanation about which person has the most convincing argument.	
	Candidates may support their judgement by considering:	
	Strength of reasoning: I logic structure balance claims	
	Authority and expertise ability to know	
	Use of language: tone – emotive, exaggerated, precise, measured clarity	
	Evidence: range of information and depth relevance sufficiency – sample source – media; internet date – how recent different types of information – fact, opinion, value, anecdote testimony – from experience and expert	
	Sources of bias or vested interest: I local interest personal interest political conomic personal values experience	
	Likely consequences or implications of the ideas presented	
	Acceptability of their values to others	
	 how likely other people are to agree with their perspective/view the extent to which the views expressed are supported by the candidate

	Level 5 (13–15 marks) Very good response Clear, credible and well supported points about which argument is more convincing. Coherent, structured evaluation of both statements with clear comparison. Refers to material from statements frequently.	
	The response contains three (or more) developed evaluative points, and may include some undeveloped points.	
	A clear judgement is reached.	
	Level 4 (10–12 marks) Good response Clear, supported points about which argument is more convincing. Evaluation of both statements, with comparison. Refers to material from statements.	
	The response contains two (or more) developed evaluative points and may include some undeveloped points. A wide range (four or more) of undeveloped but clearly appropriate points may be sufficient to enter this band at the lower level.	
	A judgment is reached.	
	Level 3 (7–9 marks) Reasonable response	
	If the response only discusses one of the statements, then limit to L3.	
	Reasonable points about which argument is more convincing. Some evaluation of both or only one statement, with an attempt at comparison. Judgements and evaluative points are partially supported or asserted. Refers to material from statements occasionally.	
	One (or more) developed evaluative points, possibly with some undeveloped points; three (or more) undeveloped points may be sufficient to enter this band at the lower level.	
	An attempt is made to give an overall judgement.	
	Level 2 (4–6) Basic response Basic points about which argument is more convincing. There may be only one statement considered in any detail, with little or no attempt at comparison. Judgements and evaluative points are partially supported and lack clarity/relevance at times. Material from statements mainly used implicitly.	
	The response contains two (or more) undeveloped points.	
	A basic judgement may be reached.

	Candidates are expected to make a judgement about the best course of action, i.e. how best to benefit from the opportunities of globalisation.	
	Candidates are likely to use and develop the material found in Sources 1 to 4, but should go beyond simply repeating or recycling without adaptation. Other material may be introduced but is not necessary to gain full marks.	
	Candidates may consider some of the following:	
	 reference to scale of impact reference to different consequences and implications for individuals/groups/government/world how long it might take to make a difference barriers to change the power of collective action, e.g. cooperation between countries/trade agreements the influence of individuals and groups on decision making the role of vested interests and power differences potential conflicts of interest difficulties in planning and coordinating improvements cost and access to resources to implement change other reasonable response 	
	The following levels of response should be used to award marks.	
	Level 5 (20–24 marks) Very good response Clear, well supported reasoning about the proposed course of action. Different arguments and perspectives are clearly considered.	
	The response contains a wide range of clearly reasoned points and/or evidence to support the views expressed, with four (or more) developed points, and some undeveloped points.	
	The response is very well-structured and a clear judgement is reached.

4	Level 4 (15–19 marks) Good response Clear, supported reasoning about the proposed course of action. Different arguments and perspectives are considered.	
	The response contains a range of reasoned points and/or evidence to support the views expressed, with three (or more) developed points, and some undeveloped points.	
	The response I generally well-structured and a judgement is reached.	
	Level 3 (10–14 marks) Reasonable response Some supported reasoning about the proposed course of action. Different arguments and perspectives are included.	
	The response contains some points and/or evidence to support the views expressed, with two (or more) developed points, and some undeveloped points.	
	The response is structured but at times difficult to follow and an attempt is made to give an overall judgement.	
	Level 2 (5–9 marks) Basic response Basic reasoning about the proposed course of action. Different arguments are included; perspectives, if present, are unclear.	
	The response relies on assertion rather than evidence but contains one (or more) developed point(s) or a range of undeveloped points.	
	The response lacks structure and is difficult to follow though a basic judgement may be attempted.	
	Level 1 (1–4 marks) Limited response Limited and unsupported reasoning about the topic in general. Different arguments may be included.	
	Level 0 (0 marks) No relevant response or creditworthy material.
