**Question 1**

Each candidate will require the following chemicals and apparatus. Labels do **not** need to include concentrations.

- (a) 100 cm<sup>3</sup> of 10 volume hydrogen peroxide, H<sub>2</sub>O<sub>2</sub>, labelled **solution L**  
(10 volume hydrogen peroxide is equivalent to 0.83 mol/dm<sup>3</sup>.)  
**This solution must be freshly prepared from newly purchased hydrogen peroxide.**
- (b) 100 cm<sup>3</sup> of potassium iodide, KI, of concentration 0.05 mol/dm<sup>3</sup> labelled **solution M**
- (c) 100 cm<sup>3</sup> of sodium thiosulfate, Na<sub>2</sub>S<sub>2</sub>O<sub>3</sub>·5H<sub>2</sub>O, of concentration 0.01 mol/dm<sup>3</sup> labelled **sodium thiosulfate solution**
- (d) 100 cm<sup>3</sup> of hydrochloric acid of concentration 0.1 mol/dm<sup>3</sup> labelled **hydrochloric acid for Question 1**
- (e) 1% starch solution
- (f) access to water and distilled water
- (g) 2 × 10 cm<sup>3</sup> measuring cylinders labelled **A** and **B**
- (h) 100 cm<sup>3</sup> conical flask
- (i) white tile
- (j) teat pipette suitable for measuring 1 cm<sup>3</sup> of liquid
- (k) stop-clock or timer which can measure to an accuracy of 1 s

**Question 2**

Each candidate will require the following chemicals and apparatus. Labels do **not** need to include concentrations.

- (a) 0.6 g of ammonium sulfate,  $(\text{NH}_4)_2\text{SO}_4$ , in a stoppered test-tube labelled **solid N**
- (b) 0.4 g of potassium chloride,  $\text{KCl}$ , in a stoppered test-tube labelled **solid O**
- (c) aqueous barium nitrate of sufficient concentration to give a positive sulfate test
- [MH][N]** (d) aqueous silver nitrate of sufficient concentration to give a positive halide test
- [MH]** (e) aqueous nitric acid of concentration  $0.5 \text{ mol/dm}^3$
- [C]** (f) aqueous sodium hydroxide of concentration  $1 \text{ mol/dm}^3$
- [MH]** (g) limewater and apparatus used to test for carbon dioxide
- (h) distilled water
- (i) pH indicator papers and chart
- (j) red and blue litmus paper
- (k)  $10 \text{ cm}^3$  measuring cylinder
- (l) splints
- (m) apparatus for a flame test
- (n) Bunsen burner and matches
- (o) rack of test-tubes
- (p) hard glass test-tube
- (q) boiling tube
- (r) stopper to fit test-tubes
- (s) test-tube holder
- (t) test pipettes
- (u) spatula

**N.B.** Small amounts of ammonia **[C][T][N]**, which can cause respiratory distress in some people, may be produced. **The laboratory must be well ventilated.**
