## General information about practical exams

Centres must follow the guidance on science practical exams given in the Cambridge Handbook.

#### Safety

Supervisors must follow national and local regulations relating to safety and first aid.

Supervisors must inform candidates that materials and apparatus used in the exam should be treated with caution. Suitable eye protection should be used where necessary.

Hazard data sheets relating to substances used in this exam should be available from your chemical supplier.

#### Before the exam

- The packets containing the question papers must **not** be opened before the exam.
- It is assumed that standard school laboratory facilities, as indicated in the *Guide to Planning Practical Science*, will be available.
- Spare materials and apparatus for the tasks set must be available for candidates, if required.

### **During the exam**

- It must be made clear to candidates at the start of the exam that they may request spare materials and apparatus for the tasks set.
- Where specified, the supervisor must perform the experiments and record the results as instructed.
   This must be done out of sight of the candidates, using the same materials and apparatus as the candidates.
- Any assistance provided to candidates must be recorded in the supervisor's report.
- If any materials or apparatus need to be replaced, for example, in the event of breakage or loss, this must be recorded in the supervisor's report.

#### After the exam

- The supervisor must complete a report for each practical session held and each laboratory used.
- Each packet of scripts returned to Cambridge International must contain the following items:
  - the scripts of the candidates specified on the barcode label provided
  - the supervisor's results relevant to these candidates
  - the supervisor's reports relevant to these candidates
  - seating plans for each practical session, referring to each candidate by candidate number
  - the attendance register.

## Specific information for this practical exam

During the exam, the supervisor (NOT the invigilator) must do all the experiments and record the results on a spare copy of the question paper, clearly labelled 'supervisor's results'.

If chemicals are prepared in more than one batch, clearly labelled supervisor's results must be provided for each batch. The candidates using each batch must be listed on the supervisor's report.

- 1 × pipette filler
- 1 × 250 cm<sup>3</sup> volumetric flask
- 2 × burette stand and clamp
- 2 × funnel (for filling burette)
- $2 \times 150 \, \text{cm}^3 \text{ or } 250 \, \text{cm}^3 \text{ conical flask}$
- 1 × white tile
- 1 × glass rod
- 8 × test-tube\*
- 1 × test-tube rack
- 1 × Bunsen burner
- 1 × heatproof mat
- 2 × teat/dropping pipette
- 1 × wash bottle containing distilled water
- 1 × pen for labelling glassware

red and blue litmus papers

aluminium foil for testing nitrate/nitrite

wooden splints

the apparatus normally used in the centre for use with limewater in testing for carbon dioxide

<sup>\*</sup>Candidates are expected to rinse and reuse test-tubes where possible. Additional tubes should be available.

FA 2 [C]	180 cm³	2.0 mol dm <sup>-3</sup> sodium hydroxide	See preparation instructions in the current syllabus.
FA 3	150 cm³	0.0353 mol dm <sup>-3</sup> sodium carbonate	Dissolve 3.74g of Na <sub>2</sub> CO <sub>3</sub> <b>[MH]</b> or 10.10g of Na <sub>2</sub> CO <sub>3</sub> .10H <sub>2</sub> O <b>[MH]</b> in each dm³ of solution.
FA 5 [C]	15cm³	0.2 mol dm <sup>-3</sup> iron(III) chloride	Dissolve 32.5g of $\operatorname{FeC} l_3$ [MH][C] or 54.1g of $\operatorname{FeC} l_3$ .6H <sub>2</sub> O [MH][C] in each dm³ of 1.0 mol dm³ HCl. The resulting solution may be very cloudy. Allow it to stand and settle then decant, or filter the solution. (Dilute 500 cm³ of 2.0 mol dm³ HCl to 1 dm³ to prepare 1.0 mol dm³ HCl.)
FA 6 [MH]	15cm³	1.0 mol dm <sup>-3</sup> sulfuric acid	See preparation instructions in the current syllabus.
FA 7	20 cm³	0.05 mol dm <sup>-3</sup> silver nitrate	See preparation instructions in the current syllabus.

aqueous barium nitrate	10cm³	0.1 mol dm <sup>-3</sup> barium nitrate	See preparation instructions in the current syllabus.  NOTE: Barium chloride is not a suitable substitute.
aqueous sodium carbonate [MH]	10 cm <sup>3</sup>	1.0 mol dm <sup>-3</sup> sodium carbonate	Dissolve 106.0g of Na <sub>2</sub> CO <sub>3</sub> <b>[MH]</b> or 286.0g Na <sub>2</sub> CO <sub>3</sub> .10H <sub>2</sub> O <b>[MH]</b> in each dm³ of solution.
